Centralia Public Library Meeting Minutes December 8th, 2022

President Baca called the meeting to order at 6:19 p.m.

Minutes: Board members reviewed the November minutes. Trustee Luke made a motion to approve the November minutes and Trustee Beckmann seconded. All in favor, motion carried.

New Business: Board members discussed how the library is caught up on paying library employees minimum wage in accordance with employment laws. This is not a requirement for our library, however, the Board has continued to increase employee wages across the board since this law was passed by voters in 2018.

Director's Report: Director Hopkins talked about attending the **MPLD** (Missouri Public Library Directors) conference on Dec.1st & 2nd., including discussion/Q&A with attorney Adam Sommer on the SOS Admin. rule, other library experiences with book challenges and other legal issues facing libraries.

Staff reviews will be conducted next week before raises become effective on Jan. 1st, 2023.
