Old Business:

- A. **Parking lot / pavilion update**: Light pole and additional lights for existing pole (*next to shed*) are back ordered and will be installed as soon as they arrive.
- B. **Front entry concrete pad** replacement will be completed by Jennings and Sons Construction, LLC. who submitted a bid/estimate of \$1,965.00. They are waiting on the repair of a piece of equipment before they can begin this project. Estimate is 2-weeks from today.

President's Report:

Director's Report:

Director Hopkins discussed several upcoming grant & funding opportunities including Dollar General youth literacy grant and ECF (Emergency Connectivity Fund). Director Hopkins applied for the DG literacy grant for a collection of STEM kits for the Library to circulate (\$4,000). ECF funding (*last round of ARPA funding*) for 50 long-term hotspots, plus funding for our existing T-Mobile hotspots was applied for. If successful, the funds received from the City of Centralia will be used to upgrade our US Cellular hotspot devices to give our patrons a choice of devices, depending on service availability at their residence.

Several pictures of events were shared with the Board including: CIS Book & Bike event which included the Paws & Pages group, SRP promotion and bookmark contest. Sam & Cait saw close to 150 kids for this literacy event. The last Storytime until SRP begins and the NF Trivia Benefit (for Neurofibromatosis) which raised close to \$4,000 to support NF Midwest. Our library team came in 5th out of 18 teams!

Trustee Dorman made a motion for the meeting to adjourn and Trustee Simmons seconded it. All in favor, motion passed. The meeting was adjourned at 6:49 p.m.
